# **Publication of Subscription Price and Subscription Ratio**

We refer to the offer published in the Federal Gazette on 19 April 2021 concerning the subscription for new shares created by the capital increase from authorized capital via a contribution in kind, as resolved by the Management Board of Vonovia SE (the "Company") with the approval of the Finance Committee of the Supervisory Board.

On 15 April 2021, the Management Board of the Company resolved, with the approval of the Finance Committee of the Supervisory Board dated 16 April 2021, to use the authorized capital under § 5.1 of the Company's Articles of Incorporation (Authorized Capital 2018), and to increase the share capital by up to EUR 19,000,000.00 through the issuance of up to 19,000,000 registered shares, each having a proportionate share in the Company's share capital of EUR 1.00 (the "New Shares"), in return for a contribution in kind upon the exercise of subscription rights. The New Shares are entitled to participate in any profits beginning on 1 January 2021.

In line with the principles for the determination of the subscription price and the subscription ratio as set out in the subscription offer, the Management Board of the Company on 7 May 2021 has resolved as follows:

The subscription price per New Share is € 50.193. The subscription ratio is 29.7: 1.

Consequently, the contribution in kind to be made for the subscription for each New Share shall be 29.7 dividend entitlements resulting from the resolution of the general meeting of the Company on 16 April 2021, each of which amount to € 1.69 per dividend-bearing share.

The subscription period runs until the end of 10 May 2021.

## **Sales restrictions**

The New Shares will only be offered to the public in the Federal Republic of Germany and Switzerland. Neither the subscription rights nor the new shares are, or will be, registered in accordance with the U.S. Securities Act of 1933, as amended (the "Securities Act"), or with the securities regulators of individual states or other territories of the United States of America. At no time may the subscription rights and new shares be offered, sold, exercised, pledged, transferred or delivered, neither directly nor indirectly, to the or within the United States of America, except to Qualified Institutional Buyers ("QIBs") as defined in Rule 144A of the Securities Act, or due to the existence of an exemption from the registration requirements of the Securities Act or in such a transaction that is not covered by them if it does not constitute a breach of applicable securities legislation in the individual states of the United States of America.
